1. Introduction

The year 2021 was just as 2020 a difficult year for all of us. The Covid-19 pandemic was still going around the world disrupting normal life. The foundation received many requests for emergency funding.

The supervisory board and board decided to extend the suspension of regular funding cycles and fund emergency requests in two rounds.

The Foundation funded a total of € 57,365 to 27 projects in the 2021 calendar year. These projects are located in 16 countries across the world.

In 2020 the supervisory board started recruitment of new board members, resulting in 4 new enthusiastic board members. It was decided to focus on the emergency funding first and to start recruiting for more members for the board and supervisory board at the end of the year.

Also, the decision was made to start with a new strategy for the coming years, once all vacancies were fulfilled.

The Foundation looks back with great satisfaction on the funded projects in 2021. We realise very well that as members of the LGBTI community in this country we have a privileged position. Unfortunately, there are so many countries in the world where there is no naturalness of a normal happy life, where you can't be yourself and where you can't love someone without condemnation. So many countries where the LGBTI community is seen as pernicious and dangerous. Any improvement in the position of LGBTI people throughout the world, no matter how small, is important. We are all equal.

The most important challenge for the new board will be to find ways to increase our funding capital, by finding more funders and sponsors and to improve our internal organisation. As a result, we can help more projects in more countries.

We thank all our current donors and especially our founder and main funder, ROMEO BV, to help us also in these difficult times.

2. Vision, mission and priority themes

2.1 PlanetRomeo Foundation

PlanetRomeo Foundation is an independent, registered non-profit charity foundation established in 2009 with the help of Romeo BV, one of the largest online dating platforms. We aim to contribute to the fight for equal rights and opportunities for LGBTI (lesbian, gay, bisexual, transgender and intersex) people all over the world.

PlanetRomeo Foundation provides funding up to € 5000,- to grassroots emerging LGBTI projects and initiatives in countries and regions where LGBTI rights are most severely infringed. In 2021, the Foundation provided emergency funding up to 2000 EURO per approved project.

2.2 Vision and mission

Vision

PlanetRomeo Foundation envisions a world without discrimination on the basis of sexual orientation, gender identity and expression or characteristics; a world in which lesbian, gay, bisexual, transgender and intersex people have the same rights and opportunities as anyone else; a world that values and respects diversity in sexual orientation, gender identity, gender expression and sex characteristics.

Mission

Our current support focuses on contributing to societal change in order to improve the position of LGBTI people throughout the world, with an emphasis on the most disadvantaged regions and communities. We also focus on mobilising and activating the LGBTI community in those challenging contexts. We do not initiate projects ourselves, and we set out to be a stepping-stone and fill funding gaps between zero funding and access to larger grants.

2.3 Funding themes

In normal times, our current policy is that we fund projects under the following themes:

- 1. Community Organising
- 2. Shelter
- 3. Sports & Culture

Because the Covid-19 pandemic was still going around the world disrupting normal life and the foundation received many requests for emergency funding, the board decided to extend the suspension of regular funding cycles and only fund emergency requests in two rounds.

In 2021, the Foundation funded 27 emergency projects, totalling € 57,365. The emergency projects could all be categorised under 'Shelter'.

3. Review of Activities

3.1 Emergency Funding

In 2021, the Foundation's aim was to help as many emergency requests as possible, within the set budget.

3.2 Fundraising activities

Our funding activities in 2021, was focused mainly on users on the ROMEO dating platform. Having this exclusive access to more than 2 million users worldwide, not only provides a generous supplement to the funding we receive from ROMEO but creates an avenue to increase awareness of the issues we support.

In addition to the income from the core funding made by our main funder Romeo BV, we are happy to say that we raised over € 47,000 from our fundraising activities.

3.3 Outreach

We continue to ensure that we are engaged and connected to the wider LGBTI world. Considering our position, we consider it important to play a role not only as a funder but in being part of the wider struggle of LGBTI+ people. To this end, we want to engage with other funders in the Netherlands and other parts of the world as a way to keep both ourselves and others informed about our work and landscape of LGBTI struggle. Because of the pandemic this goal was not reached in 2021.

3.4 Policy

Our funding prioritises small-scale projects as a way to inspire and encourage action. These projects must be initiated, led and implemented by the LGBTI community groups and initiatives. Such projects, in many cases, do not qualify for mainstream or other funding due to lack of credentials and formal incorporation. To be eligible, they must aim to involve, empower and mobilise the community. For 2021 we focussed only on emergency projects.

We ensure that projects we fund have at their hearts, the community spirit of bringing people together and safety. In all situations, we prefer group involvement and decision-making rather than single person projects. To this end, we do not pay funds into personal bank accounts or sole-trader accounts.

We continued to fund two categories of emerging initiatives:

- ✓ [relatively] new, informal LGBTI groups or organisations with little or no access to other sources of funding;
- ✓ more experienced LGBTI organisations that develop new initiatives for which they have not yet previously received funding, and for which are difficult to find funding elsewhere.

Due to recent developments in certain Western industrialised countries, we have slightly reviewed geographical eligibility to include some countries in the European Union. Although projects from all geographical regions remain eligible, we continue to prioritise projects in countries outside the Global North. For the purpose of this policy, Global north is defined as Western European Union countries, Iceland, Norway, Switzerland, the United Kingdom, Australia, Canada, New Zealand, United States of America.

Report from the Supervisory Board

The Supervisory Board met several times in 2021, mostly digital, sometimes in a physical meeting. The Covid-19 situation was a regular topic and the consequences for the Foundation. Also, recruiting new board members was on the agenda. These Meetings with the Management Board included review and adoption of the 2020 annual report as well as the approval of the 2021 budget. Furthermore, the two Boards discussed the option of Emergency Funding to support the LHBTI+ community. Other matters relating to the continuous improvement of the Foundation and its governance were discussed and reviewed.

No new members joined the Supervisory Board in the 2021 calendar year. The Supervisory Board is happy with the new members for the Management - and Supervisory Boards who started beginning 2022.

Governance and strategic direction

The current Strategic Plan of the Foundation came to an end in 2020. The Management and Supervisory Boards looked into how to set a new strategy for the Foundation. Since the Foundation operated with a small board in 2020 and 2021, the decision was made to postpone the new strategy until all vacancies in both boards were fulfilled. The most important challenge for the new board will be to find ways to increase our funding capital, by finding more funders and sponsors, to improve our internal organisation and to become more independent from our founder Romeo BV. As a result, we can help more projects in more countries identification.

4. Financial summary and budget

4.1 2021 budget

The budget for 2021 was set ambitiously.

4.2.1 Donations

Donations to the Foundation in 2021 breaks down as follows

4.2.2 Project funding

The Foundation granted funding to 27 projects to the tune of €57,365. This amount represents the total awarded instead of the total paid out.

This is because the Foundation uses an instalment system that makes payment in 2 or 3 instalments depending on the total awarded and the length of the project.

4.2.3 Fund releases

In some cases, a grant – or part of it – may be terminated for any reasons, ranging from the inability of the project to continue, project, reporting lesser expenses than were originally budgeted or not meeting [their] stated goals, amongst other potential factors. As such, in 2021, no money was released from affected projects.

4.2.4 Overhead and service agreement

Both the management board and the supervisory board work on a voluntarily basis and do not receive any compensation.

The asset management of PlanetRomeo Foundation is in line with both the guidelines for Dutch ANBI for registered non-profit organisations and those set by the Dutch Central Bureau of Fundraising (Centraal Bureau Fondsenwerving). These guidelines suggest that a non-profit ANBI must spend at least 90% of its expenses usefully in general. The management costs of the ANBI must be in ter identification.

What is 'reasonable' depends (among other things) on the nature of the ANBI Management costs are costs are cost for the management of the institution, such as costs associated with conducting administrative management

In light of the above, the Foundation's total overhead cost for the year amounted to 27,4%

However, it must be noted that the service agreement with ROMEO BV is also a donation-in-kind which includes the provision of staff, office space and other sundry services. When this donation is balanced by deducting the service agreement from the total income and then calculating the remaining costs, the Foundation's cost amounts to 5,4% of the remaining income.

4.2.5 Staff

PlanetRomeo Foundation did not have any employed staff in 2021. The staff services were provided by Romeo BV as a part of the service agreement.

4.3 Budget 2022

Based on the activities in 2021, including costs, incomes, planned improvements to systems and processes, and other planned enhancements, the budget for 2022 is slightly lower.

4.4 Notes to the 2022 budget

Income

PlanetRomeo Foundation receives an annual donation from its founder and core funder, ROMEO BV. In 2021, this donation amounted to €80,000, and an additional €38,405 donation-in-kind in the form of service agreement. The latter accounts for services like staffing, office space and other sundry items. This in-kind donation is balanced in the accounting as both income and expenses to ensure maximum transparency.

Overhead

As of the time of making the budget for 2022, the Foundation sets an objective to bring in a new digitised application and a grant management system. This increased the potential expenditure of the operating cost for the years to come.

To ensure that our overhead stays within guideline and that most of our income goes to project funding, a review of the potential Grant-Making Systems will be taken before the final decision is made. Ultimately our funding income has to increase the coming years.

5.3 Accounting policies

Statutory objectives

PlanetRomeo Foundation is a Foundation ('stichting') according to Dutch law. It has its legal seat in Amsterdam, The Netherlands and is registered at the Dutch Chamber of Commerce under registration number 34350443. Its statutory objectives are:

a. obtaining funds for the benefit of charities including the interests of the lesbian, gay, bisexual, transgender and intersex (LGBTI) communities, such as in the fields of education, culture, gay rights, health, empowerment and sports, as well as to support other activities that could contribute to this goal; amongst others in order to, respectively by the funds available at the disposal of the aforementioned goals, in the widest sense of the word; and

b. carry out all that with the above - in the widest sense - is related or may be conducive thereto.

Accounting policies in respect of the valuation of assets and liabilities
The annual accounts have been compiled in accordance with the Dutch Guidelines
on Annual Reporting for Fundraising Organizations (Richtlijn 650 Fondswervende
instellingen).

The accounting policies adopted for the valuation of assets and liabilities and results are based on historical costs principle. Unless otherwise stated, assets and liabilities are stated at nominal value.

Accounts receivable

Receivables are stated at nominal value. If necessary, a provision for bad debts is subtracted.

Liabilities

The liabilities are stated at their nominal value.

Other reserve

The other reserve is relating to the total free capital of the Foundation. In the case of discontinuation of the Foundation, the eventual positive balance will be used for purposes in line with the objectives of the Foundation.

Accounting policies in respect of result determination

In determining the result, revenues and expenses are allocated to the year to which they relate.

6. Perspective on 2022

With the arrival of a new chair and two new members of the Management Board and of a new member of the Supervisory Board, end of January 2022, along with the end of government restrictions due to Covid, the Foundation closes an uncertain and difficult period.

The new management board decided to focus first on finalising the emergency project fundings of 2021, to start a tender for a Grand Management System, to reorganise the internal processes, to establish a fundraising note, to establish a communications note and review the service agreement with Romeo BV. With regard to the Service agreement, the management board has indicated that parts of the activities from the agreement will be performed by the board itself.

The plan is to start new project funding in the 3th quarter of the year. A new Strategy Plan for the coming three years will also be presented in that quarter.
